IPM statement

It is the goal of Perris Union High School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

The pest management objective for the Perris Union High School District is to focus on long term pest prevention using the safest methods through monitoring and inspection methods.

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Western Exterminator, Wildlife Control Services, M&O Staff and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

District kitchens are inspected monthly and treated by Western Exterminator. Schools are monitored and inspected daily by Custodians and Plant Supervisors. Athletic fields and grounds are monitored by Groundskeepers. Issues and complaints are forwarded through the district's work order reporting system.

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
