IPM statement

It is the goal of Perris Union High School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: (Example: Focus on long-term pest prevention)

The pest management objective for the Perris Union High School District is to focus on long term pest prevention using the safest methods possible through monitoring and inspection methods.

Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

Pest identification, monitoring and inspection

Pest Identification is done by: Western Exterminator Company & Wildlife Control Service, Inc.

(Example: College/University staff, Pest Control Business, etc.)

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Western Exterminator, Wildlife Control Service, Custodial, Maintenance & Operations Staff and results are communicated to the IPM Coordinator.

(Example: District staff title, e.g. Maintenance staff)

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include: (Example: Sticky monitoring boards are placed in the kitchen and are checked weekly by custodial staff.)

District kitchens are inspected monthly and treated by Western Exterminator. Schools are monitored and inspected daily by Custodians and Plant Supervisors. Athletic fields and grounds are monitored by Groundskeepers. Issues and complaints are forwarded through the District work order system to Maintenance & Operations Department, who will contact Western Exterminator & Wildlife Control Service as needed.

Chemical pest management practices

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained balts or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
